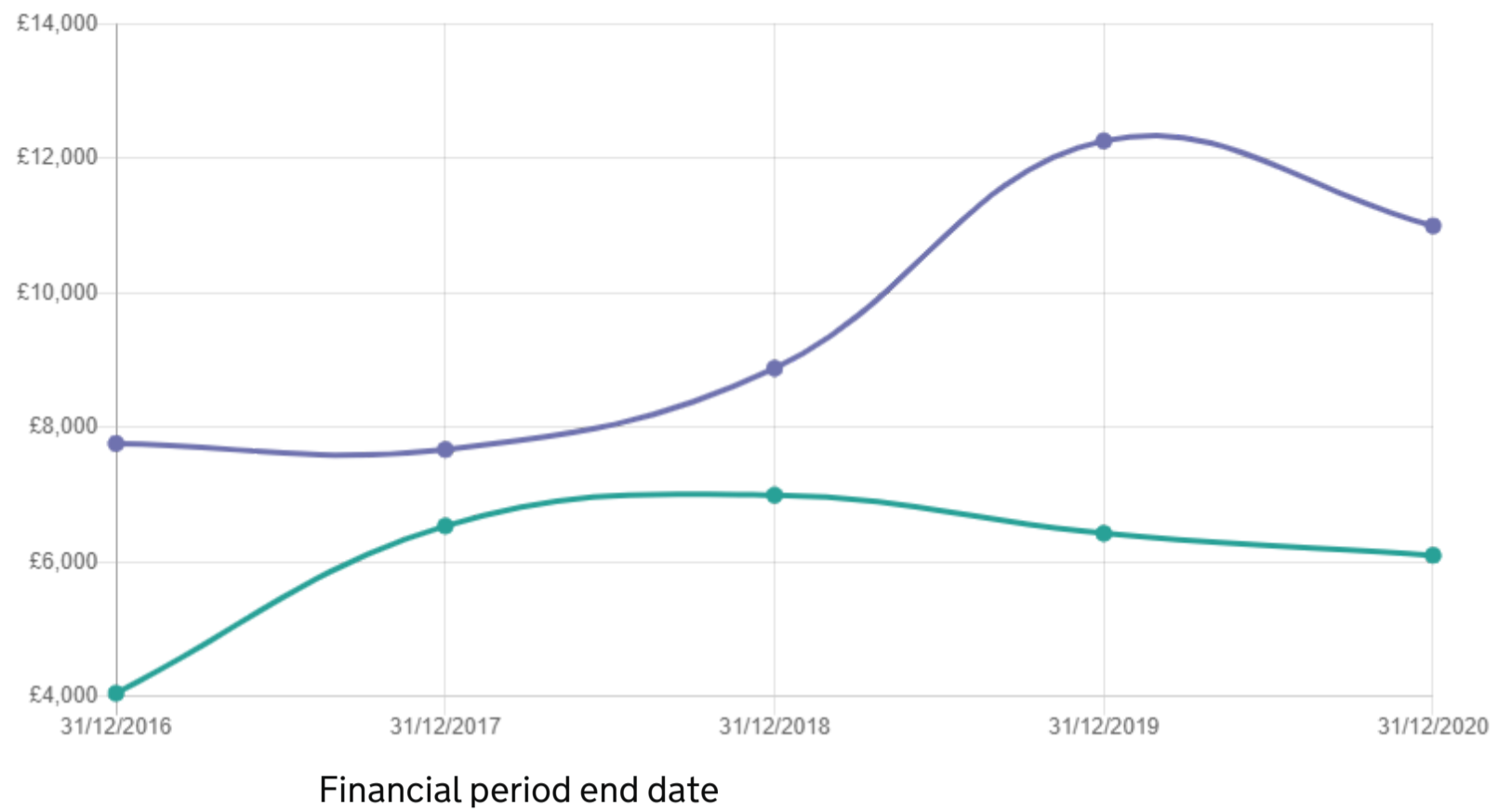
# Trustees
